2. Weeds -

- a. Update on current conditions & agency priorities for weeds within the 6 county region
 - i. CMR Paula Grouse On the east end, Leafy Spurge is the main problem being addressed with station funds and staff. An invasive species strike team came out and did a few inventories. In 2013 they treated Saltcedar on the east end. CMR has undertaken several control efforts but the amount of weeds versus the available funds is drastic. A private contractor was brought in to perform control efforts on West End Whitetop, Hoary Crest, and Russian knapweed. Saltcedar & Russian olive are distributed across much of the refuge. Most all of the money for control efforts is from refuge funds and strike team funds. Canada Thistle is another big problem.
 - ii. ACOE Patricia Gilbert (off handouts) The ACOE is focused on Leafy Spurge, Spotted Knapweed, Diffused Knapweed, Russian Knapweed, Canada Thistle, Saltcedar, and Eurasian Watermilfoil.

The ACOE is using limited funds annually (\$70K for FY 2016) to manage over 400,000 acres of land and water, including 1,540 miles of shoreline. The primary goal is to provide a method of prioritizing management strategies and allocating limited resources by surveying, mapping, and treating noxious weeds; eradicating small infestations and providing long term containment of larger infestations to prevent movement to non-infested areas while minimizing negative impacts to native vegetation and existing natural resources. They are working on biological controls on project lands and surveying and monitoring.

3. Tourism & Recreation -

- a. Update on contacts to the tourism industry.
 - i. Jeremy Sage working with NWF.
 - ii. Eastern Montana bison restoration effects on tourism and infrastructure needs to handle increase in tourism. A panel survey will be sent out to an email list of about 3000 people (residents and nonresidents) on what they want to see when they tour that area.
- b. Better define parameters/priorities for the work.
- c. Need to have clarifications in place to ensure any economic comparisons are examining similar figures (direct \$ to direct \$ to indirect \$) with regard to tourism and agriculture dollars.

4. Returning Young Folks to the Community -

- a. Presentation of economic indicators within the region.
 - i. Additions need to be to Travis by November 1st.
 - ii. It was figured that Julie Haggerty with (MSU) should be put on the agenda for a future meeting.
- b. Better define parameters/ priorities for the work.

5. CMR Sage Grouse Committee -

a. Conservation Menu – Rachel handed out a draft form of the menu and stated that the committee will look for final approval at the September 15, 2016 meeting in Lewistown. The meeting should be available by join me for those who cannot travel.
