- What is the USFWS study about? Need to have discussion about this survey that is regarding introducing bison and bighorn sheep on CMR
- Fort Peck test flows below the Dam affecting area greatly, and beyond area as well
- APR purchases concern, most recent in Valley County
- Ranches this year have been treated worse this year than illegals coming across the southern border by our federal government
- Focusing on relationship building
- Want action out of this group, don't want it to become a book club
- CMR resources and understaffing issues
- Need to get rid of the bison threat/issue
- In Valley County, ordinance passed saying all bison in county are domestic
- Ranchers cannot survive with free ranging bison
- Ranchers are losing respect
- Concerned about the people of these small communities
- CWG discussions are very important and want to continue this information sharing occurring
- More people coming to the West, and Montana specifically, how do we work with that
- Understanding local concerns and needs
- Discussion on FWP's Elk Management Plan and information about elk on the CMR
- May need more sportsman representation on CWG, elk hunting issues
- Worried about the future and what is going to happen down the road on the CMR
- Trail use within BLM / other public access lands vehicle use on 2-tracks verse hiking
- Developing relationships within the group has been the biggest benefit
- Bringing concerns and sharing perspectives is huge part and benefit of CWG
- Current drought conditions are bad, acres that never greened up
- Invasive species control and information including saltcedar and Japanese brome, potential change in habitat as result
- Fire regimes in CMR Refuge area, change in timber areas, fuel treatments
